The meeting will be of interest to those that are, or will be, involved in projects for which culverts will be designed and constructed, as well as monitored, maintained, and prioritized for upgrade and replacement. The meeting program will include sessions that provide discussions about design examples, construction, maintenance, and region-specific case histories for various types of culverts.</p> <p>As with previous training sessions, attendees will have an opportunity to participate in a tour of various sites to view existing conditions and efforts similar to those discussed during the classroom session.</p> <p>Unlike past years when support funds for printing, supplies, etc. were available through the CBFWA, costs associated with this year's event must be absorbed by proceeds from registration fees. As a result, the registration fee for this year's training session was increased to accommodate the increased cost of convening the event.</p>
